Course:

Start on N. Mountain Ave., cross I-5, right on E. Nevada, right on Pompadour Dr., right on Pilot View Dr., turn and trace back to N. Mountain (approx. 5 mile mark), left on Eagle Mill, under I-5, continue right on Eagle Mill at intersection with Oak St., right on Butler Creek Road (approx. 7 mile mark), cross over I-5, right on Ashland Ln. (dirt), left on Irish Ln. (dirt), left back onto Butler Creek Rd. and trace back to Eagle Mill, turn right, take to Bear Creek Greenway parking area, u-turn and head back to Ashland on the Bear Creek Greenway bike trail, follow to Ashland Dog Park (at the intersection of W. Nevada St. and Helman St.), right on W. Nevada St., left on N. Laurel St., left on W. Hersey St., continue to E. Hersey St., left on N. Mountain Ave., right on paved bike trail in N. Mountain Park (near the start), finish near the N. Mountain Nature Center.

To Enter:

Participants can register in person at Rogue Valley Runners (RVR) by May 21st or mail in entries to RVR by May 17th. Packet pick-up will be held at RVR (161 East Main Street) on Friday May 21st from 10-7. Race day check-in 7:45-8:45 at North Mountain Park.

Cost:

Early entry fee: \$30, short sleeved tech tee to those entered before May 21st.

Race day entry fee: \$35, shirts limited to supplies on hand.

Checks can be made out to Rogue Valley Runners. No refunds.

Finisher awards to all participants. Prize money awarded to the top three male and female finishers.
