**To Enter:**

Participants can register in person at Rogue Valley Runners (until 3/9/12) or mail entries to Rogue Valley Runners (until 3/5/12). Race day entry and packet pick-up will be available at 7:00am near the start area. Checks can be made out to Rogue Valley Runners. No refunds.

**Cost:**

Early entry fee: \$25, includes short-sleeve technical tee  
Student entry fee: \$15, includes short-sleeve technical tee  
Race day entry fee: \$30, tee included ONLY until supplies last  
Age group awards will be presented after the race.
